

Online Safety Schools Competition

Terms and Conditions: “We can all be safer online with...”

1. Acceptance of competition terms & conditions:

1.1 This competition, called the “We can all be safer online with...” competition is run by Netsafe Incorporated (“Netsafe”) (“the Competition).

1.2 Entrants may win one of the following prizes:

1.2.1 First prize: School stationery pack to the value of \$100, and a Whittakers chocolate pack to be shared with your class and family.

1.2.2 Second prize: School stationery pack to the value of \$50.

(collectively referred to as the Prize(s)).

1.3 Children must ask their parents or guardians first before they enter this Competition.

1.4 If you do not agree to these terms and conditions, you may not enter and you are not eligible to redeem the Prize.

1.5 Netsafe reserves the right to vary, suspend or terminate the Prize(s) at any time, without notice to you.

2. Who can enter?

2.1 To be eligible to enter this Competition, entries must be completed by children, or a group of children, that are in primary, intermediate or secondary school, at the time of entry submission.

2.2 Children may have help from teachers, parents or guardians in order to help them to submit their entries via email to outreach@netsafe.org.nz.

3. How to enter?

3.1 To enter to win, you must create either a hand drawn, digitally drawn poster or shoebox diorama of your primary school’s online safety mascot, which includes the completed messaging of “We can all be safer online with...” (Entry).

3.2 Scan or take a photo of your Entry and submit it to Netsafe to outreach@netsafe.org.nz

3.3 Entries will be accepted from individual students as well as Entries that have been submitted by the whole class.

3.4 All Entries must be submitted by 3pm on 23 August 2021.

4. **Winner notification and announcement:**

- 4.1 Netsafe, in conjunction with an external judge from the education sector, will judge each Entry and select the Winner(s), based on the quality and how well the judges believe the Entry connects and communicates the messaging of “staying safe online”.
- 4.2 Netsafe will notify the winner (either directly or via their parents or guardian, whose information has been submitted with each Entry).
- 4.3 The Winners will be announced on Netsafe’s social media channels and contacted on 1 September 2021 via the email that was used to submit the Entry.
- 4.4 Netsafe reserves the right to select another winner if the initial winner does not respond within 72 hours of notification.
- 4.5 Netsafe’s decision regarding the Winner(s) is final, and no correspondence will be entered into.
- 4.6 The Prizes will be sent to the nominated address for each Winner, which will be collected from the Winner(s) following Netsafe contacting the Winners.

5. **Publicity:** Entrants agree that their name and a description of their prize may be published on Netsafe’s social media channels, within email marketing or on Netsafe’s websites, only with parental or guardian consent.

6. **Liability:** To the fullest extent permitted by law, Netsafe shall not be responsible for any loss, damage or injury whatsoever suffered by any winner resulting from their use of the Prize(s) (including but not limited to any direct, indirect, consequential, special, punitive or incidental loss or damages). Netsafe’s liability to any entrant or prize winner will be limited in any circumstances to a maximum for all claims up to the value of the Prize.

7. **Privacy:** Netsafe will collect and hold personal information such as the entrant’s name, contact details (if any), their school, and the parents or guardians contact details (if any) in order to notify you if you win, in accordance with our Privacy and Information Statement.
